

Before joining, it's important you know:



Our facilities are protected by:

- a) Controlled Access Membership Cards
- b) By cameras inside and outside the building
- c) By filtered ventilation and air quality that is properly monitored
- d) By the constant patrolling of Certified Range Officers, and
- e) By ensuring safety regulations are being strictly enforced.

Before using the range, everyone will be given a safety briefing, which includes a tour. Members or Guest who don't abide by the rules are subject to losing their privileges.

The Waiver you must sign is explained below:

The waiver is necessary to you obtaining access to membership and the range

In signing the waiver you are agreeing (in the first part) that

1. You are using this Gun Range at your own risk.
2. That, you are not under any prohibition from handling firearms.
In other words, the police or a probation officer would not be upset if you were here.
3. That you know, by law we make all our records available to all law enforcements.
4. You understand that this document will affect your legal rights if something should happen.
So we encourage you to understand it before signing.

Some of it is in legal terms, so I'll give you a brief summary of what is in each Section and then allow you time to read it.

In Part A, you acknowledge:

- a) That guns are used and fired on this property and that they are potentially dangerous.
- b) That even though you may not know everything about guns, you use the facilities at solely your own risk
- c) That you are responsible for your own conduct & safety as well as those you bring as guests.
- d) That shooting exposes you & your guest to lead particles & other harmful health contaminants
- e) That those under 18 or pregnant are at higher risk to these contaminants

In Part A, you are also agreeing to:

- a) Follow all warnings and all instructions given to you
- b) To practice safe shooting habits & behaviors
- c) That any pictures or videos you take can only be for personal use. No business, or public use unless you get permission.

In Part B, you are saying that:

- a) **Regardless the cause, you release the owners, employees and volunteers, of *Hnatiuk's and Scotia Club* from all claims or damages, of any loss or injury (including loss of life) in connection with you using this facility.**

In Part C, you are saying that:

- a) *Hnatiuk's* have all rights associated to any pictures or video recorded here that are being used in a way that is not permissible. And
- b) *Hnatiuk's are not responsible for any cost or damage arising out of the posting of any pictures or video recorded here.*

In Part D, you are saying that:

Hnatiuk's are not responsible for liabilities and or cost which they may suffer as a result of something you or your guest does.

You understand that ***Hnatiuk's*** reserves the rights to not grant you access and to terminate your access should they see fit.

You are telling us you have the authority to sign this document.

In the closing remarks,

- a) It reiterates that regardless any legality; you are using this facility at your own risk.
- b) That you will follow all safety rules
- c) That this information is confidential but may be released to police or other authorities. and
- d) That any disputes about this document shall be governed by the laws of NS & Canada

Lastly

Fill out the information required at the bottom and sign.

If you have any questions, let one of our membership staff know when you drop in to have your membership processed.

Reminder to New Members:

Your personalized Access Card:

- a) Each Membership Access Cards is programed with your photo, your personal & contact information, your start and end dates for access into the Club facilities. Your card will allow you to unlock the club doors at pre-arranged times to let yourself in.
- b) If you arrive at the club with other members (and the door is open), ensure you swipe your card to record your arrival. This is not required on departure.
- c) Your arrival and departure (and all those with you) will be recorded on high quality video.
- d) **If you loose your Access card**, report this to our membership staff ASAP, or call Jim Hnatiuk ASAP. (902 471-3209)
